STAFF REPORT: Grants and Cooperative Agreement Program

SUBJECT: Grants Program Update

Summary

As required by the regulations governing the Grants and Cooperative Agreements Program (Grants Program), the 2016/17 (G16) grants cycle began with the opening of the application process on January 9, 2017.

Discussion

On March 6, 2017, applicants submitted their preliminary application for OHMVR Division and public review. The OHMVR Division comments were sent out to applicants during the first full week of April 2017.

The Intent to Award was posted on the OHMVR Division website on June 5, 2017. No appeals were received during the 30-day appeal period that ended on July 5, 2017. All awards are now final. A copy of the Final Awards listing all successful applicants and the awards received is attached.

Additionally, with this grant cycle, the OHMVR Division is implementing a process to capture unused grant funds from previous grant cycles. This process is consistent with the legislative intent of the Grants Program to fund all eligible applications to the extent feasible.

Public Resources Code section 5090.50(a)(1)(D) provides for any unencumbered funds under the Operation and Maintenance category be used in future grant cycles for purposes consistent with that grant category. For the G16 grant cycle, the OHMVR Division has developed a "Contingency List – Operations and Maintenance".

As allowed per current statute, and in working with the departmental budget office, the OHMVR Division will be utilizing funding not used during the 2014/15 (G14) grant cycle (2015/16 state budget) to fund projects listed on the Contingency List (Operation and Maintenance). The projects on this list went through the same competitive process as those listed on the 2016/17 Final Awards for the categories of Ground Operations, Development and Planning. Additionally, the projects are eligible and qualified projects

that were not funded in the Operation and Maintenance category because they fell below the funding cut-line.

The OHMVR Division has received final approval from the Department of Parks and Recreation Director. The Grant Administrators will work with the successful applicants to prepare agreements for the projects.

While working on developing the project agreements, Grants staff will also approve payment requests from prior grant cycles and close out open projects.

Finally, the Grants staff will begin work on the next grant cycle which is set to begin on January 8, 2018.
