

**Title 14. Natural Resources
Grants and Cooperative Agreements Program Regulations**

**NOTICE OF MODIFICATION TO TEXT OF PROPOSED REGULATIONS AND
ADDING DOCUMENT TO RULEMAKING FILE**

NOTICE IS HEREBY GIVEN the California Department of Parks and Recreation (Department), pursuant to the requirements of Government Code section 11346.8(c) and section 44 of Title 1 of the California Code of Regulations, proposes modifications to the California Code of Regulations, Title 14, Division 3, Chapter 15, Title 14, Division 3, Chapter 15, Articles 1 and 4, Sections 4970.06.1, 4970.06.2, 4970.06.3, 4970.07, 4970.20, and Grants and Cooperative Agreements Program – Appendix (Appendix) (1/22; incorporated by reference).

This regulatory proposal was the subject of a 45-day comment period from June 11, 2021, through July 26, 2021, and a regulatory hearing on July 27, 2021.

Notice is also given that an Addendum to the Initial Statement of Reasons (Addendum) is available for public review and will be added to the rulemaking file pursuant to Government Code section 11347.1.

RESULTS OF THE ECONOMIC IMPACT ANALYSIS/ASSESSMENT

Notice is also given to the determination statement made in the 45-day Notice concerning the results of the economic impact analysis.

Part of the determination made in the 45-day Notice was inconsistent with statements made in the ISOR relating to the economic impact on businesses.
