

ITEM 1. Proposed Project

The Bureau of Land Management (BLM) Eagle Lake Field Office (ELFO) boundary includes approximately 1,022,767 managed surface acres in Northeastern California and Northwest Nevada. The geographic area includes BLM administered lands within the counties of Lassen, Plumas, Sierra, California and Washoe, Nevada. The BLM's mission is to sustain the health, diversity and productivity of the public lands it manages for and the use and enjoyment of present and future generations. This grant will provide essential Law Enforcement funding for the areas managed within California.

The BLM Eagle Lake Field Office managed lands include those utilized for multiple activities such as, camping, hiking, birding, hunting, fishing, horseback riding, driving for pleasure, grazing, and OHV riding on designated routes and open areas. The ELFO staff currently manages a variety of designated areas for multiple use such as Wilderness Study Areas (WSA), Special Recreation Management Area's (SRMA) and an Extensive Recreation Management Area (ERMA), Area's of Critical Concern (ACEC) and Special Designations such as Wild and Scenic Rivers and Historical Trails. Most of these areas are only accessible through use of OHV's and need regular OHV patrol to protect natural resources and the rights of OHV users who abide by the existing laws and regulations. Change in recreation use and population growth has resulted in user conflicts and increased concern for negative impacts to cultural and natural resources and an increased demand for use of public lands. Public interest has expanded to emphasize aesthetic values such as open space and scenic values to recreation.

The BLM, Eagle Lake Field Office (ELFO) staff and Law Enforcement Ranger provide frequent educational outreach through the use of brochures, handouts, websites, field contacts, events and partners. During routine patrols, the BLM law enforcement officer hands out public information documents on rules and regulations 5 days a week, verbally educates the public, and conducts sound tests as needed. The BLM ELFO staff is available 5 days a week by telephone or in person. Information on public lands managed by the BLM, including OHV specific information is available at the BLM Field Office in Susanville, Ca. The BLM California Website and Eagle Lake Field Office website contains the most up to date information regarding BLM managed lands including information on the designed OHV area, Fort Sage Off- Highway Vehicle (OHV) Special Recreation Management Area (SRMA).

This Law Enforcement grant request will provide an additional outreach tool for both the BLM Law Enforcement Ranger and staff through the designing and printing of an OHV specific brochure for the Fort Sage OHV SRMA. The BLM and Lassen Motorcycle club members (LMC) will work together to provide additional public outreach using the brochure to both LMC members and the general public during special events and non-events within the Fort Sage OHV SRMA. The ATV and safety equipment purchase will allow the BLM Law Enforcement Officer to provide outreach and enforcement to users in remote areas where only ATV's can travel. The purchase of the motion capture device (in car camera) will ensure the BLM Law Enforcement Officer and safety, provide evidence, and credibility. The purchased GPS unit, Trimble GEO XT and the necessary TerraSync software will be utilized by the BLM Law Enforcement Officer to locate various areas, record findings, such as dump sites, illegal routes and criminal acts, and to provide outreach tools such as maps and brochures. Recon flights will be conducted for intrusions into the ACEC and Wilderness Areas. Funding will also be used to conduct a clean-up of OHV areas where household and commercial waste has been dumped.

ITEM 2. Project Coverage

The BLM, Eagle Lake Field Office Law Enforcement Ranger is assigned to patrol a total of 1,022,767 acres. The BLM Eagle Lake California managed lands are 978,103 acres.

ITEM 3. Describe the frequency of the patrols

Federal Law Enforcement Rangers patrol BLM lands a minimum of 40 hours a week including weekends, holidays and after hours. The Susanville Interagency Dispatch Center is available 7days a week. The BLM, Law Enforcement Ranger assigned to the BLM Eagle Lake Field Office Patrols the area 5 days a week focusing on areas with high OHV use and user group conflicts. In addition, the Eagle Lake Outdoor Recreation Planner, Seasonal Maintenance worker and Maintenance staff patrol the recreation areas on foot and through OHV's for user conflicts, issues, and conduct trash pickup and visitor services.

ITEM 4. Deployment of Personnel

There is one Law Enforcement officer assigned to the BLM, Eagle Lake Field Office managed lands. A minimum of 75 percent of the Law Enforcement time is spent conducting OHV patrol and education.

Areas with high priority for Law Enforcement of OHV use include four Areas of Critical Concern, seventeen known cultural sites to be designated as Cultural Resource Management Areas, four Wilderness Study Areas and four Special Recreation Management Areas, one Extensive Recreation Management Area, two of the areas are specially designated for OHV use, two other areas not designated as official OHV areas also receive high OHV use. Many of the designations listed above contain sensitive species, cultural sites, and areas of cultural significance and provide for a wide variety of multiple uses where conflict between users groups frequently occurs.

2. Describe how the proposed Project relates to OHV Recreation and will sustain OHV Recreation, motorized off-highway access to non-motorized recreation, or OHV Opportunities associated with the Project Area:

This project will provide the enforcement of State and Federal OHV regulations CVC codes and 43 CFR specific laws relating to OHV use and ensure user compliance and education. Additional funding for Law Enforcement will provide the protection of natural, historical and cultural areas and reduce future conflicts. Additional Law Enforcement funding will help to protect the rights of users who respect regulations and the conservation of natural resources. The project will limit the potential damage created through OHV use to habitats, wildlife and cultural sites and provide for long term OHV recreation, ensure the protection of the environment and improve the overall recreation experience relating to safety.

The BLM Eagle Lake Field Office Law Enforcement Ranger frequently works with the surrounding BLM and Forest Service jurisdiction Law Enforcement Officers, and Lassen County Sheriff's department.

BLM patrol staff is trained to identify public safety hazards and to respond to emergencies. Staff training includes first responder; ATV Rider Safety; ATV Rider Safety Instructor; sound testing and spark arrestor identification. LEOs work closely with BLM wildlife and archaeology personnel to address environmental and cultural resources that may be threatened by OHV use. Additionally, enforcement rangers attend an annual mandatory training in the enforcement of 43 CFR, including OHV laws and carry the Off-Highway Vehicle Law Enforcement Information booklet published by California State Parks.
