6. Jurisdiction:

Santa Clara County Park Rangers are the primary law enforcement personnel within the 457-acre OHV Park. The Park Rangers patrol 22 miles of trails, various tracks, and parking lots within the park. Park Rangers and park staff monitor and patrol the entrance into the park. Park Rangers patrol all areas of the park by motorcycle and ATV's. Foot patrols are also conducted in the parking lots, picnic sites, and spectator observation areas. Park Rangers patrol the park for any OHV Code, CVC, and county ordinance violations and take immediate corrective action. They also assist the public by answering their questions about general information or riding conditions at this location and at other local state OHV areas.
