Additionally, the lack of comments by the OHMVR Division to any specific applicant does not ensure successful results for the applicant within the competitive grant process or a commitment of funding.

All final applications will be reviewed by the OHMVR Division. The OHMVR Division may, at its sole discretion, decrease the requested amount and eliminate activities pursuant with regulation Section 4970.07.2 (f)(1-5) and for law enforcement projects, regulation Section 4970.15.3(b)(1-5).

Failure by applicant to respond to any OHMVR Division comment of their preliminary application shall be cause for eliminating that item from the applicant's application.

If multiple proposed projects are requesting funding for the same deliverable, and multiple projects are successful, only one project will receive funding for the deliverable.

For proposed projects requesting grant funding for snow and/or winter activities. Applicants must ensure the activities and/or equipment requested are not and/or cannot be funded by the OHMVR Division Winter Program (commonly referred to as the Snow Grooming Program).

For proposed projects requesting grant funding for the maintenance of roads and/or trails, note that only roads and/or trails that allow "green sticker" off-highway vehicles are allowed to receive grant funding.

Applicants are reminded that no grant funds and/or match can be expended or project activities conducted in any land owned or managed by the California Department of Parks and Recreation.

Evaluation Criteria

- #4 - Applicant cannot claim themselves as a partner. Applicant must list each partner separately and provide an explanation for how the listed partners are partners to this Education and Safety project.
- #5 - Selections are not addressed in the Project Description; “ATV”, “4X4”, “Motorcycle”, and “Recreation Utility Vehicle (RUV)/Side-by-Side”. Applicant must provide additional information substantiating all selections made.
- #14 – Selections are not supported in the Project Description. Applicant must provide detail on how the project will have the majority of personnel trained in “Radio communication”, “ATV”, and “4x4/Off-Road training.”
- #15 – Narrative does not support the selection. Applicant must revise accordingly.
