- Contracts, "Other – permanent lights" – This appears to be a Development activity and should not be included in the Ground Operations grant.
- Equipment Use Expenses, "Equipment Rental" – These costs appear to be excessive. Applicant may want to provide additional information.
- Others, "Printing" – This cost appears to be excessive. Applicant may want to provide additional information.
- Others, "Postage" – This cost appears to be an indirect cost.
- Others, "Utilities" – This cost appears to be an indirect cost.
- Others, "Other-Office Supplies" – This costs appear to be indirect costs. Several items in, "Other-Office Supplies", such as website and internet fees do not appear appropriate for a Ground Operations project.

- Others "Other - advertisement", "Other - computer", "Other – property tax", and "Other – travel, conference, training" do not appear appropriate for a Ground Operations project. Applicant may want to provide additional information.
- Others "Other – Aluminum bleachers" appear to be a duplicate from a prior grant. Applicant may want to provide more information
