- C – Response does not appear to relate to the proposed project.
- D – First two paragraphs do not appear to respond to this item.

**Project Cost Estimate**

- Staff – Not clear how “Park Attendant”, “Archilogist”, and “Recreation Planner” will be utilized/relate to this project as described.
- Staff – “Grant Administrator” may be more appropriate under “Administrative Costs”.
- Contracts – Not clear how/for what purpose “Billboards” will be utilized in this project.
- Materials / Supplies – Not clear how items listed in this category will be utilized/relate to this project as described.
- Other – Not clear how “internet costs” will be utilized/relate to this project as described.
