Agenda items will include: Under Unfinished Business: Commission will consider applications, take testimony and allocate funds for 2006/07 Local Assistance Grants and Cooperative Agreements. The Consent Calendar will be considered first, followed by the project types: Conservation, Enforcement, Restoration, and Non-CESA. Unless the Commission modifies the order, the projects will be called in the order they appear on the spreadsheets available on the website and at the Commission meeting. The Commission, where appropriate, will provide Commission reports.

Under New Business: At the start of the meeting on Friday, January 26, 2007, the Commission will hold a closed session to discuss Pending Litigation: Ecologic Partners, et al. v. California Department of Parks and Recreation, et al., Sacramento County Superior Court Case No. 06CS00115. (Government Code §§ 11126(e) (1) & (e) (2) (A).)

On Saturday, January 27, 2007, the Commission will hear a briefing on from the Division, and the Contractor, on the Fuel Tax Study: *Estimating the State Fuel Tax Paid on Gasoline Used in the Off-Highway Operation of Vehicles for Recreation*. In addition, pursuant to Public Resources Code 5090.24 (f), the Commission shall conduct one public meeting annually, prior to the start of each grant cycle, to collect public input concerning the program, recommendations for program improvements, and specific project needs for the system.
