**SUBJECT:** Proposed Eastern Kern County Acquisition Update

---

### Summary

Since the September 20, 2013, Off-Highway Motor Vehicle Recreation (OHMVR) Commission meeting, the Eastern Kern County Acquisition (EKCA) Final Environmental Impact Report (EIR) was released. The Notice of Determination for the EKCA Final EIR was filed with the State Clearinghouse on October 4, 2013 (see Attachment 1).

On October 18, 2013, California's Public Works Board approved the EKCA project for site selection. This approval allows the OHMVR Division to begin property acquisition negotiations.

### Discussion

The OHMVR Division is proposing to acquire 50 privately-owned parcels (approximately 25,000 acres) in eastern Kern County, California, from ReNu Resources, LLC. The proposed acquisition lands are due west of Red Rock Canyon State Park and are interspersed in checkerboard fashion amongst land owned primarily by the Bureau of Land Management (see Attachment 2).

In accordance with CEQA, the OHMVR Division circulated a Draft EIR for the EKCA project from February 15, 2013, through April 1, 2013. On October 3, 2013, the OHMVR Division approved the acquisition project and adopted the EIR findings including a statement of overriding considerations. Additionally, the OHMVR Division adopted the Eastern Kern County Property Acquisition Mitigation, Monitoring, and Reporting Plan. Project Description:

The OHMVR Division is proposing to acquire up to 59 privately-owned parcels (approximately 28,275 acres) in eastern Kern County, California, from ReNu Resources, LLC. The parcels are interspersed with lands owned by the Bureau of Land Management in the western Mojave Desert, approximately 20 miles north of Mojave and west of State Route 14. Off-highway vehicle recreation occurs on many of the parcels, largely on designated roads and trails. The project comprises purchase and management of the parcels for recreation and resource protection.


