SUBJECT: Election of Off-Highway Motor Vehicle Recreation Commission Chair

Summary

The position of Chair is currently vacant. Public Resources Code (PRC) Section 5090.19 directs that the Commission shall elect a Chair. At this point in time, the position of Chair needs to be refilled for the remainder of the current term.

Discussion

Pursuant to Public Resources Code (PRC) Section 5090.19, the members of the Commission shall elect a Chairperson from their number who shall serve as Chairperson for a one year term and until his or her successor is elected.

Since the Commission was created in 1983, Commissions have implemented PRC Section 5090.19 as follows:

May 7, 1983: "The elected officers of the Commission shall be Chairman and Vice-Chairman. The Chairman shall not serve two consecutive terms, and consideration shall be given to alternating among the Commissioners from Southern California and Northern California." It was followed up with, "Officers shall be elected annually at the March meeting and will take office immediately following their election."

May 17, 1985: "The elected officers of the Commission shall be a Chairman and Vice-Chairman. The Chairman may not serve more than two consecutive terms, and consideration shall be given to alternating among Commissioners from Southern California and Northern California."

May 18, 2001: "The elected officers of the Commission shall be the Chair and the Vice Chair. Elected officers may serve more than one term."

Commission Action

Elect a Chair to serve for the remainder of the existing term or until a new Chair is elected.
