Special Event/Special Use Permits—Businesses, organizations and race series promoters hold events and trainings throughout the year. Approved permits for commercial photo/film are required. Contact the special event coordinator at 916-985-5642 or PCEvents@parks.ca.gov.

PLEASE REMEMBER

- Practice tracks are groomed once a week and watered as necessary, given adequate staff and equipment.
- Know before you go: visit the OHV FAQ page at ohv.parks.ca.gov/ohv_faqs.
- All vehicles must display an ID plate or placard issued by DMV. Fuel combustion engines must have a USFS-approved spark arrester.
- Use of ROVs/ATVs require each person to wear a DOT-approved helmet.
- OHMVR Day-Use Annual Pass is available at the entrance station for \$50.
- No potable water for drinking or washing equipment.
- OHV rentals exist off-site and must be hauled in by customer only.
- Posted orders on the park's main web page include, but are not limited to, hours of operation, drones, wet weather closures and special events.
- Tread Lightly! Treat others with safety and respect, use existing trails, educate yourself, avoid sensitive areas and do your part by leaving your areas clean.
- Animals, plants and wood are protected by law and may not be disturbed. Notify staff of rattlesnake sightings inside staging areas.

You are responsible for knowing park rules and regulations. All provisions of the California Vehicle Code are enforced and can be found at ohv.parks.ca.gov/laws_and_safety. If you have questions, please contact the park staff or call 916-985-7378.

PARK RULES AND REGULATIONS

Any motor vehicle operated off-highway is an OHV. A highway-licensed vehicle is an OHV when operated off of the highway. Vehicles having green and red stickers are OHVs.

- **Alcohol**—Open container and DUI laws apply off-highway just as they do on-highway. Don't drink and drive.
- **ATV Laws**—Operator MUST wear a helmet anytime the vehicle is in motion. Passengers are NOT allowed unless the vehicle has a factory manufactured second seat.
- **Dogs**—Dogs must be on maximum 6-foot leash at ALL times and physically under control. Please pick up after your dog.
- **Noise Emissions**—The law limits noise emissions from all OHVs. Noise emissions for most OHVs are limited to not more than 96 dBA. For more specific information, go to: ohv.parks.ca.gov/noise_emissions.
- **Respect the Safety of Others**—Speeding and unsafe turns (donuts) are never allowed in parking areas or on roads.



PRAIRIE CITY STATE VEHICULAR RECREATION AREA

WELCOME! Ride on, you made it! The park comprises about 1,350 acres of state land, of which more than 800 acres are currently devoted to off-highway vehicle (OHV) recreation. Prairie City State Vehicular Recreation Area is a showcase for OHV recreation, including major competitive events and terrain that provides a range of recreational opportunities to OHV enthusiasts of all ability levels. Major OHV uses at the park include motorcycles (M/C), all-terrain vehicles (ATVs), four-wheel drive vehicles (4x4s) and recreational off-highway vehicles (ROVs/SxSs/UTVs). The current OHV riding area is divided into four major zones. In addition to OHV trails in these zones, key park OHV facilities include: MX (motocross) and ATV practice tracks, Kids MX and ATV tracks, trials bike areas, 4x4 area and obstacle course, quarter midget oval track, kart track concession and Pro-Am MX Track concession.

THINGS TO DO

If you have time, familiarize yourself with the park map, drive along the main roads to observe signage, riding areas and practice tracks. Tour the 4x4 area if you have an appropriate vehicle, visit the kart track, have a picnic or watch riders in action from the main staging area. View the park's events calendar before visiting at ohv.parks.ca.gov/PrairieCityEvents or scan the QR code below.

If you have half a day or more, check the current hours of operation and the events calendar (for potential area closures). Bring your registered OHV with proper OHV ID or vehicle registration with necessary personal protective gear, water and food/snacks. Riding areas/trails/tracks are open daily during regular business hours, and each have designated use posted.

For ADA accessible features, there are several accessible staging areas with parking available on a first-come basis. Many include a shaded ramada with picnic table, fire pit and barbecue. ADA parking spaces with shaded ramadas are available in the main staging area and the 4x4 staging area.

TRAINING CENTER

The Environmental Training Center (ETC) at the park, exists to teach safe and environmentally responsible off-highway recreation practices. The facility consists of a classroom, two training ranges and a 3-acre trail system landscaped with California native plants. The vehicle trail system allows trainers to instill respect for the land and observe sustainable trail building techniques, while challenging participants to real-life riding conditions. Be an off-road hero, train for the trail!
