- #7b Narrative does not support the selection. It is unclear whether the majority
  of the OHV opportunity areas are patrolled at least once per week. Deduct 3
  points.
- #9a Narrative does not support the selection. Applicant did not develop a systematic methodology that is consistent with the 2020 Soil Standard. Deduct 5 points.
- #11a Narrative does not support the selection of "bulletin boards, signs or kiosks...". It is unclear if the signage board describes safe and responsible OHV recreational practices. Deduct 5 points.
- #11c Narrative does not support the selection. Applicant did not provide a
  detailed explanation to support the daily onsite effort to provide information on
  safe and responsible OHV use. Deduct 4 points.

Deduct \$135 from Grant and \$165 from match based on average market price for a shop toolbox (could not move the cost to the Indirect Costs category as Project is over the allowable 15% maximum indirect amount). Revised total for this line item is now Grant \$2,436 and match \$738.

• Indirect Costs #1 "Indirect Costs" – Applicant has now exceeded the 15% allowable. Deduct \$9 from Grant and \$12 from match. Revised total for this line item is now \$16,130 Grant and \$5,659 match.
