 Contracts #3 "Social Media Campaign" - Applicant's methodology is still unclear as the Applicant's quote was created June 2nd, which is after the preliminary Application filing date.

- Equipment Use Expenses #2 "4x4 Pickup Truck…" Use fee appears excessive. A search for 4x4 vehicles in the Victorville area from Budget, Enterprise, Hertz, and Thrifty car rentals finds daily rental rates ranging from \$75 to \$131, with an average rate of \$101 per day. Reduce rate to \$101. Deduct \$4,508 from match. Line item total is now \$9.292 match.
- Equipment Use Expenses #4 "4x4 Pickup Truck...." Use fee appears excessive.
   A search for 4x4 vehicles in the Victorville area from Budget, Enterprise, Hertz,
   and Thrifty car rentals finds daily rental rates ranging from \$75 to \$131, with an
   average rate of \$101 per day. Reduce rate to \$101. Deduct \$98 from match. Line
   item total is now \$202 match.
- Indirect Costs #2 Due to deductions, Applicant fell below the required 25% minimum for match. Applicant shall move \$3,001 from indirect Grant to indirect match. Line item total is now \$4,499 Grant and \$3,001 match.

- Contracts #8 "Visitor Map Cartography" Applicant is reminded maps, videos and/or handouts that display the "OHV Trust Funds at Work" logo must be reviewed and approved by the OHMVR Division prior to publication.
- Equipment Use Expenses #3 "4x4 Pickup Trucks" Applicant increased the Grant request for this line item without receiving a Division or public comment. The line items reverts back to the original preliminary amount of Grant \$37,500 and match \$112,500. In addition, the use fee appears excessive. A search for 4x4 vehicles in the Victorville area from Budget, Enterprise, Hertz, and Thrifty car rentals finds daily rental rates ranging from \$75 to \$131, with an average rate of \$101 per day. Applicant must reduce the Rate to \$101. Deduct \$36,260 from Grant and \$12,740 from match. Revised total is Grant \$1,240 and match \$99,760.
- Indirect Costs #1 "Project Coordinator" Applicant increased the Grant request for this line item without receiving a Division or public comment. Deduct \$20 from Grant and \$0 from match. Revised total is Grant \$40,000 and match \$0.
- Indirect Costs #2 "Administrators" Applicant removed "bookkeeping," "payment processing," "safety training," and "audits" activities from the line item but did not reduce the line item total. Applicant listed eight (8) activities for this line item. Removing four (4) activities reduces the line item total by 50%. Deduct \$20,000 from Grant. Revised total for this line item is now Grant \$20,000 and match \$0.

#### **Evaluation Criteria**

- #3 Project Description does not support the selection of "Maintaining trail or road tread for single vehicle use." In addition, Narrative does not support the selection of "Providing varied levels of riding difficulty." Applicant did not provide examples of Project activities being performed that support the selection. Deduct 2 points.
- #7 Project Description and/or Project Cost Estimate sections do not support the selection of "Other products with recycled content." Applicant already made this selection under the erosion control selection. Deduct 1 point.
- #8 Narrative does not support the selection of "Camping" and "Other." Applicant did not provide specific Project examples supported by the Project scope that support the selections. Deduct 4 points.
