- #8 – Applicant must clarify what “scheduled educational talks” is, as it appears to be an Education & Safety activity.

### **Project Description – All Others**

- Describe the size of the specific Project Area(s) in areas and/or miles – Both the Applicant and Friends of El Mirage are proposing Ground Operations activities on BLM – Barstow Field Office managed land. Applicant needs to clarify how they will ensure no duplication of services.

### **Project Cost Estimate**

- Staff #1 & 4 – Line item Rate appears excessive compared to similar Projects. Applicant must provide additional details to justify Rate.
- Contracts #2 “Vault Toilet Cleaning” – Cost appears excessive. Applicant must further define how the cost was determined. In addition, Applicant must clarify the source of match.
- Materials / Supplies “Fencing Material” – Cost appears excessive. Applicant must further define how the cost was determined.
- Equipment Use Expenses #1 “Motor Grader Rental” – Cost appears excessive. Applicant must clarify the need for motor grader rental for 12 months compared to the quantity of routes being maintained. In addition, Applicant must provide the weekly rental rate. Applicant is reminded that the rental rate selection should result in cost savings for the State.
- Equipment Use Expenses #2-5 – Applicant must clarify specifically how the Equipment will be used on the Project.
- Others #2 “Gooseneck Trailer” – Applicant requested a “Gooseneck Trailer” in the previous year’s Application as well as its Recreational Trails Program (R24) Application. Applicant must clarify whether it purchased, or intends to purchase, this trailer and/or need to purchase a similar type of equipment in this year’s Application.

## **Law Enforcement: G25-01-04-L01**

### **Need Assessment**

- Item #1 – Applicant is advised that patrolling for anything other than OHV Recreational activities is not eligible for Project activities as they do not have an OHV nexus.
  - For example, patrolling for the following is not eligible: trespassing, illegal camping, marijuana growing sites, vandalism, target shooting, illegal firearms, dumping, campfires, lost hikers, homeless, and burglary.
- Item #4 – Applicant must clearly define the planned number of officers dedicated to OHV patrol, outline the number of days allocated for patrol (per week, considering weekdays, holidays, etc.), and rank of personnel assigned to patrol duties.
