  Applicant must justify the cost. Lastly, dependent upon Applicant's response, this
  activity may be moved to Staff or Contracts.
- Others #3 "Travel Fees" Applicant must clarify the need for an equipment operator and contracted labor for maintenance as the Project is a planning Project and cannot contain Ground Disturbing work.
