- #1a-c – The dates cited in #1a and 1c are inconsistent. #1c indicates data was updated in 2025. However, #1a dates are listed as years 10-2025 through 09-2026. Applicant must verify their response and clarify why the Applicant lacks a recent twelve-month period with accurate OHV Opportunity and visitation data as Applicant provided a future date.

#### **Need Assessment**

- Item #3 – Applicant must provide additional detail estimating the number of shifts per officer during the Project Performance Period.
- Item #4 – Applicant must provide additional detail outlining the number of days allocated for patrol (per week, considering weekdays, holidays, etc.), and rank of personnel assigned to patrol duties.

#### **Needs Enforcement Certification**

- #6 – Applicant must provide additional details identifying curriculum used to train personnel in OHV safety and natural and cultural resource protection. Applicant must include a descriptor for, "special tactic", training identified in Item #1 of the Law Enforcement Needs Assessment section.

## **Project Cost Estimate**

- Staff #2 “Supervisory Law Enforcement Rangers” –Notes are unclear for hours requested. Applicant must revise to clarify if they are asking for 806 labor hours or 420 labor hours.
- Staff #3 “Law Enforcement Technician” – Applicant must substantiate the law enforcement technician is qualified and certified to administer preventative and scheduled maintenance of OHV law enforcement vehicles.
- Staff #4 “Detailed Law Enforcement Rangers” – Applicant must estimate the number of shifts per officer during the Project Performance Period.
