- Equipment Use Expenses #1 "UTV Rental" Applicant must provide justification and supporting evidence for selection of the unit of measurement. Applicant must include in its justification how the selection results in cost savings for the State.
- Equipment Use Expenses #2 "truck rental" Equipment transportation expenses are reimbursed based on per mile charge, not exceed the Internal Revenue Service standard mileage business rate, up to one hundred (100) miles in each direction per day. Applicant must describe in the notes section how costs were determined and change the unit of measurement to "MI".
- Others #2 "tracked carrier rental" Applicant must move this line item to Equipment Use Expenses category. In addition, Applicant must provide an applicable rental cost to justify line item Rate.
- Others #3 "t-post and wire fencing barrier" Applicant must move this line item to the Materials / Supplies category. In addition, line-item notes appear duplicative with Materials / Supplies #8. Applicant must remove one line item or explain the need for separate line items.
- Others #4 "grading work on ML 2 rds" Line item is considered contract activities. Applicant must move this line item to Contracts category.
- Others #5 "spot asphalt repairs on Rockfront Road" Applicant must provide activities to be performed on the Project. In addition, Applicant must define how the costs were determined.
