## Law Enforcement: G25-03-72-L01

### **Need Assessment**

 Item #1 – Applicant is requesting a ROV and OHV trailer but fails to state if the Project includes purchasing new Equipment in this section. Applicant must provide a justification for why the new Equipment is needed.

## **Project Cost Estimate**

- Material / Supplies #3 "ROV Back Up Camera" Applicant must provide additional justification for this line item. In addition, Applicant is reminded that Equipment purchased through the Grant Program or used 100% for OHV patrol is eligible for vehicle upgrades. Applicant must clarify what pieces of Equipment these upgrades are intended for and if the piece of Equipment was acquired through the Grants Program or used 100% for OHV patrol. This line item is also considered indirect as it does not directly relate to the completion of the Project. Applicant must move this line item to the Indirect Costs category.
- Materials & Supplies #4 "Factory UTV Skid Plates/Protection" Applicant must further define how the cost was determined. In addition, Applicant is reminded

- that Equipment purchased through the Grant Program or used 100% for OHV patrol is eligible for vehicle upgrades. Applicant must clarify what pieces of Equipment these upgrades are intended for and if the piece of Equipment was acquired through the Grants Program or used 100% for OHV patrol.
- Equipment Use Expenses #1- 2 Fuel Cost Cost increased compared to the prior year's Application. Applicant must provide additional notes on how fuel costs were determined.
- Equipment Purchases #1 "CanAm Commander Max XT-P 4-seat ROV" –
  Applicant needs to specify the rationale and need for acquiring this piece of
  Equipment. Applicant purchased and then disposed of a 2023 CanAm in that was
  to be replaced and must address why an additional ROV is needed on top of the
  replacement. Per disposal agreement the agency was to replace this vehicle and
  the purchased vehicle was to become part of the Law Enforcement Grant funded
  Equipment inventory. In addition, cost appears excessive. Applicant must further
  define how the cost was determined.
- Others #1 "Replacement OHV Trailer" Applicant must identify what percentage
  of use Trailer will be used for this Project and adjust the line-item cost
  accordingly to reflect that percentage of use.

## **Project Cost Estimate**

- Staff #1-2 "Sergeant and Deputy Patrol OT"

  Applicant must provide OHV duty descriptors showing how duties relate to OHV enforcement. In addition, the cost increased compared to the prior year's Application. Applicant must provide additional details to justify the cost.
- Materials / Supplies #1 "Snow Suits" Applicant must confirm and provide justification of these line items, considering they were requested in the same quantity in the G24 Application. Applicant must also provide clarification for the increased cost of this item, as it was significantly less expensive in the prior year's Application.
- Materials / Supplies #2 "Snow Gaiters" Applicant must confirm and provide justification of these line items, considering they were requested in the same quantity in the G24 Application.
- Materials / Supplies #4 "Jet Boil Stoves" Line item is considered indirect as it
  does not directly relate to the completion of the Project. Applicant must move this
  line item to the Indirect Costs category.

- Materials / Supplies #5 "Waterproof Bags" Line item is considered indirect as it does not directly relate to the completion of the Project. Applicant must move this line item to the Indirect Costs category.
- Materials / Supplies #8 "First Aid Kits" Applicant must provide clarification for requested medical kits and list contents of kit. Applicant to justify how they are specific/specialized to OHV patrol.
- Materials / Supplies #11 "Gas Can" Line item is considered indirect as it does not directly relate to the completion of the Project. Applicant must move this line item to the Indirect Costs category.
- Materials / Supplies #13 "Cargo Straps" Line item is considered indirect as it
  does not directly relate to the completion of the Project. Applicant must move this
  line item to the Indirect Costs category.
- Materials / Supplies #14 "Cargo Containers" Line item is considered indirect as it does not directly relate to the completion of the Project. Applicant must move this line item to the Indirect Costs category.
- Materials / Supplies #15 "Emergency Blankets" Applicant must provide clarification for the requested item. Applicant to justify how they are specific/specialized to OHV patrol to be considered Direct.
- Equipment Use Expenses #3 "Annual Maintenance" Applicant must separate
  the cost of service for the OHV funded 2017 Jeep and SkiDoo Snowmobiles into
  separate line items. Cost significantly increased compared to the prior year's
  Application. Applicant must provide additional details to justify the cost.
- Other #1-5 Cost appears excessive for each line item. Applicant must further
  define how the cost was determined for each line item. In addition, line items are
  considered indirect as they do not directly relate to the completion of the Project.
  Applicant must move these line items to the Indirect Costs category.
- Other #6 "Roll Cage for Jeep" Applicant must provide additional justification for this line item, considering that Jeeps come equipped with a factory-installed roll cage that is sufficient for OHV patrol activities. In addition, Applicant is reminded that Equipment purchased through the Grant Program or used 100% for OHV patrol is eligible for vehicle upgrades. Applicant must clarify what pieces of Equipment these upgrades are intended for and if the piece of Equipment was acquired through the Grants Program or used 100% for OHV patrol.
- Other #7 "RK9A Premium Recovery Kit" Cost seems excessive for this item.
   Applicant must provide clarification for the requested item, list contents of kit, and justify how the contents of the recovery kit are specific/specialized to OHV patrol to be considered Direct.
- Others #9 "Tools and Parts" Line item is considered indirect as it does not directly relate to the completion of the Project. Applicant must move this line item to the Indirect Costs category.
- Other #10 "Satellite Wi-Fi Router" Line item is considered indirect as it does not directly relate to the completion of the Project. Applicant must move this line item to the Indirect Costs category.
