Applicant must clarify that the same or similar Equipment was not purchased in the previous year's Grant cycle.
- Item #2 Applicant must indicate whether the agency is patrolling and/or performing other Project activities outside the agency's land jurisdiction.
 Applicant is reminded that Project funds can only be used for OHV patrol with an OHV nexus (i.e., lost hikers, theft, and mutual aid calls are not eligible Project activities). Applicant must revise the section to remove any ineligible activities

- Staff All Line Items Applicant must provide OHV duty descriptors showing how duties relate to OHV enforcement.
- Equipment Purchases #1 "Polaris Ranger Crew XP1000 Northstar" Applicant did not adequately justify the need for the Equipment, given Applicant already has two UTVs in their fleet to achieve the Project deliverables. In addition, Applicant is reminded that maintenance costs for Grant funded Equipment can be requested in Applications.
- Equipment Purchases #2 "Ford F250 Crewcab Pickup" Applicant must clarify what percentage of the Project's use the Equipment will be used for and adjust the line-item cost accordingly to reflect that percentage of use.
- Others #6 Applicant must clarify what type of decals these are. If they are routine decals, they are considered indirect, and Applicant must move to the Indirect Costs category.
