- Staff #1 & 2 Applicant is reminded that time identifying resource damage and wilderness intrusions from OSV usage must be billed to the OSV grooming contract.
- Materials / Supplies #1 "Safety Equipment" It appears that the quantity and rate have been reversed. Applicant must revise.
- Materials / Supplies #2 "GPS Units" It appears that the quantity and rate have been reversed. Applicant must revise. In addition, Applicant must clarify if these will be attached to the OHV Equipment.
- Equipment Use Expenses #2-5 Applicant must identify which pieces of OHV
 Grant funded Equipment will need annual service/maintenance. The Applicant is
 reminded that costs exceeding \$750, not found in the manufacturer's
 recommended maintenance schedule, is considered a Major Repair.
- Equipment Use Expense #5 "Trailer Maintenance" Applicant must move the line item to the Others category as Trailers not considered Equipment.
- Indirect Costs #1 "Medical Training" Medical/EMT Training is not an eligible Project cost. Applicant must remove the line item from the Grant Application.
