- Staff #6 & 7 Applicant must provide the number of staff performing the Project activities and how the hourly rate was determined. In addition, line items appear duplicative; Applicant must remove one line item or explain the need for separate line item.
- Contracts #1 "ACE/CCC/TCSOIC/GVSS/CHIPS" Cost appears excessive.
 Applicant must clarify how the cost was determined.
- Contracts #2 "Mojica Trails" Applicant's notes are inaccurate and need to be revised. The line item Quantity and Rate need to be updated to match the line item notes.
- Materials / Supplies #1 "Toilet Pumping, Rental" Cost appears excessive.
 Applicant must clarify how the cost was determined. In addition, line item activities are considered contract expenses. Applicant must move this line item to the Contracts category.
- Equipment Use Expenses #2 "Heavy Equipment Transporation Cost" Applicant must clarify how the cost was determined.
- Equipment Use Expenses #2 "OHV Fuel" Applicant must describe in the notes section how fuel costs were determined (a per-mile charge provided for the methodology would be acceptable).
