- Materials / Supplies #2 "Safety Gear" Totals in line item per District and rate do not match. Applicant must revise line item rate to match that in the notes for each District.
- Indirect Costs #9 "Tactical Vests/Protective Jackets" The Applicant is advised that the purchase of tactical vests is not an eligible Project item. The Applicant must remove this item.

Needs Enforcement Certification
