Additionally, the lack of comments by the OHMVR Division to any specific Applicant does not ensure successful results for the Applicant within the competitive Grant process or a commitment of funding.

Failure by the Applicant to respond to any OHMVR Division comment of their preliminary Application may be cause for eliminating that item from the Applicant's final Application.

All final Applications will be reviewed by the OHMVR Division. The OHMVR Division may, at its sole discretion, decrease the requested amount and eliminate activities pursuant with regulation Section 4970.07.2 (f)(1-5) and for Law Enforcement Projects, regulation Section 4970.15.3(b)(1-5).

### **Law Enforcement: G25-03-41-L01**

#### **Need Assessment**

- Item #2 – Applicant is reminded that the Project may only include enforcement of CVC § 38000, and enforcement of OHV use on roads, streets, and highways (e.g. Operational Area 3) are ineligible Project activities. Applicant must revise the section to remove any ineligible activities.

#### **Needs Enforcement Certification**

- #3 – Applicant states that they work closely with local and Federal agencies for OHV enforcement. Applicant must state if a specific MOU or other written agreement exists with those agencies.

#### **Project Cost Estimate**

- Staff #1 "Staff Deputies" – Applicant must explain and justify the 580% increase in the requested quantity of hours and the 29.5% increase in pay rate in comparison to the previous year's Grant cycle.
- Staff #2 "Staff Sergeants" – Applicant must explain and justify the 386% increase in the requested quantity of hours and the 23.1% increase in pay rate in comparison to the previous year's Grant cycle.

- Materials / Supplies #1 "PPE/Uniforms" – Applicant is advised that Uniforms specific to OHV are considered an indirect cost. Applicant must move this line item to the Indirect Costs category.
- Equipment Use Expenses #1 "ATV Service" – Applicant must explain and justify the 83% increase in the requested rate in comparison to the previous year's Grant cycle.
- Equipment Use Expenses #3 "ROHV Service Polaris General" – Applicant must explain and justify the 50% increase in the requested rate in comparison to the previous year's Grant cycle.
- Equipment Use Expenses #3 "ROHV Service Honda 1000" – Applicant must explain and justify the 87.5% increase in the requested rate in comparison to the previous year's Grant cycle.
- Equipment Purchases #2 "Lift kit and install for 2020 Jeep Rubicon" – Applicant is advised that spare tires (e.g. "tires-5" and "wheels-5") specific to OHV are considered an indirect cost. Applicant must move one of the tires and wheels quantity under this line item to the Indirect Costs category.
