- Contracts #1 "Electrical Contractor" Line item request is greater than the total indicated in the contract. Line item reduced to contract total of \$868,789. Grant request reduced by \$15,818, and match request is reduced by \$5,558. Revised total for this line item is now Grant \$642,903 and match \$225,885.
- Indirect Applicant has now exceeded the Indirect 15% maximum. Deduct \$2,373 from Grant.

- #11 Narrative does not support the selection. Project Description and Project Cost Estimate do not support the partner organizations. Deduct 2 points.
- #13 Narrative does not support the selections. The selected offsite impacts
  were not included in the Applicant's Project Description, Deliverables or
  Background. Additionally, expansion of camping facilities does not address the
  offsite impacts selected. Deduct 5 points.

#### **Project Cost Estimate**

- Contracts #1-3 & 5 Contingent line items. Applicant must clarify "soft match", as it is not allowed in the Contracts cost category.
- Materials / Supplies #3 "Maintenance Supplies" Applicant must define how the line-item cost was determined. In addition, Applicant must move items not associated with maintenance, and their associated costs, to their separate line items (i.e. Trail maps and small equipment) within the category.

#### **Evaluation Criteria**

- #3 Narrative does not support the selection of "Providing varied levels of riding difficulty". Applicant did not provide example(s) of Project activities performed on this Project that support the selection. Deduct 1 point.
- #6 Narrative does not support the selections of "Protecting special-status species" and "Re-routing trails to divert away from riparian/wetlands areas".

- Applicant did not name a special-status species. In addition, the Project does not include re-routing of trails. Deduct 2 points.
- #7 Project Description and/or Project Cost Estimate sections do not support selection of "Signs, sign posts or education kiosks..." are made with recycled materials. Applicant states "preference is always given to... recycled content", which implies it may not be used. Deduct 1 point.

 Contracts #1-3 – Contingent line items. Applicant must clarify 'soft match', as it is not allowed in the Contracts cost category.

#### **Evaluation Criteria**

- #3 Narrative does not support the selections of "Maintaining trails that provide for multi-use" and "Providing varied levels of riding difficulty." Applicant did not provide examples of Project activities being performed that support the selections. Deduct 6 points.
- #4 Narrative does not support the selection of "The Applicant held a meeting(s), held either in-person or virtual, with multiple distinct stakeholders...". The stakeholder meeting did not include multiple distinct stakeholders. Deduct 1 point.
- #7 Background and/or project description does not support the selection of "Barrier materials which include recycled content or materials obtained onsite." Applicant stated "natural barriers are included" but did not provide examples. Deduct 1 point.
- #8 Background and/or Project Description does not support the selections of "Camping", "Birding" and "Other". Applicant does not clearly state how the Project improves and/or maintains facilities that provide motorized access to non-

motorized recreation opportunities within the Project Area where trail maintenance is being performed. Deduct 6 points.

## **Project Cost Estimate**

- Staff #2 "Seasonal or Full Time Park Aides" Contingent Line item. If awarded, Applicant must state how many staff will be performing these Project activities.
- Equipment Use Expenses #1 "Crawler Loader" Contingent Line item. If awarded, Applicant must clarify how the Equipment will be used on the Project.
- Equipment Use Expenses #2 "Water Truck" Contingent Line item. If awarded, Applicant must clarify how the Equipment will be used on the Project as "equipment used at OHV Park for trail maintenance work" appears to be related to a Ground Operations activity.
- Equipment Use Expenses #3 "Vehicle Mileage Expense" Applicant is reminded that Equipment fuel expenses are reimbursed based on actual cost, not per-mile charge. If awarded, Applicant must describe in the notes section how fuel costs were determined (a per-mile charge provided for the methodology would be acceptable) and change the unit of measurement to "Each" or "Miscellaneous."

#### **Evaluation Criteria**

- #2 The narrative does not support the selections of "Bodies of Water" and "Soils- Potential for mass wasting." Applicant did not explain the type and severity of impacts that might occur if the Project is not funded for the selections. Deduct 5 points.
- #4 The Project Description section and the narrative do not support the selections of "Best Management Practices" and "Identification of alternate OHV routes...". Applicant did not provide adequate details in the Project Description or the narrative to support the selections. Deduct 4 points.

- #7 The narrative does not support the selection of "The Applicant held a
  meeting(s), held either in-person or virtual, with multiple distinct stakeholders...".
   Applicant did not list how the public was notified. Deduct 1 point.
- #10 The narrative does not support the selection. The "underlying problem that resulted in the need for the Restoration Project" has not been resolved, as illegal incursions are still occurring. Deduct 3 points.
- #11 The Project Description section does not support the selection of "Greater than 10 acres..." of sensitive habitats which will be actively restored within the Project Area. Applicant did not provide enough details to support active Restoration (i.e., chunking/pitting/mulching) occurring on greater than 10 acres of sensitive habitats. Deduct 5 points.
