- #9a Narrative does not support the selection. Applicant did not develop a systematic methodology that is consistent with the 2020 Soil Standard. Deduct 5 points.

 #11 - OSV monitoring is included in their OHMVR Division funded Grooming contract. Applicant must remove the language and costs associated with this activity.

### **Project Description – All Others**

#### **Project Cost Estimate**

- Staff #6 "Rec Officer, Managers, Specialists" Applicant's notes do not match the line item "Quantity" (QTY). Applicant must revise the QTY to match. Deduct \$153 from Grant and \$51 from match. In addition, Applicant included "OSV Monitoring" which is not an eligible cost as it is included in their OHMVR Division funded Grooming contract. Applicant listed eleven (11) activities for this line item. Removing one (1) activity reduces the line item total by 9%. Deduct \$8,124 from Grant and \$2,708 from match. Revised line item total is now Grant \$89,112 and match \$20,416.
- Staff #7 "Rec. Technicians, Trail Specialists" Applicant included "OSV Monitoring" which is not an eligible cost as it is included in their OHMVR Division funded Grooming contract. Applicant listed nine (9) activities for this line item. Removing one (1) activity reduces the line item total by 11%. Deduct \$21,744 from Grant and \$7,248 from match. Revised line item total is now Grant \$216,824 and match \$17,752.
- Contracts #1 "ACE/CCC/TCSOIC/GVSS/CHIPS" Contingent line item. Applicant must clarify how the cost was determined.
- Equipment Use Expenses #3 "OHV Fuel" Applicant's notes do not match the line item "Quantity" (QTY). Applicant must revise the QTY to match. In addition, chainsaw fuel must be moved to the Other cost category. Deduct \$1,546 from Grant and move \$1,300 to Other cost category. Revised total for this line item is now Grant \$1,554 and match \$0.

#### **Evaluation Criteria**

- #3 Narrative does not support the selection of "Providing varied levels of riding difficulty." Applicant did not provide examples of Project activities being performed that support the selection. Deduct 1 point.
- #8 Background and/or Project Description sections do not support the selections of "Hunting" and "Fishing". Applicant did not clearly state if those opportunities are accessed by motorized use within the Project Area where trail maintenance is being performed. Deduct 4 points.
