- 1. To ensure the health and safety of persons and property on lands administered by the Department of Parks and Recreation, Desert Division, Ocotillo Wells SVRA, Salton Sea SRA, Indio Hills Palms Property, Picacho SRA, and Heber Dunes SVRA, for the safety and welfare of the public, the following restrictions are in effect:
 - A. Only wood and untreated wood products free from metal, petroleum products, or other toxic substances shall be used for campfires or recreational fires.
 - B. No person shall import, transport, or possess any wood, plastic, or fiber pallets with the intent to use for campfires or recreational fires.
 - C. No person shall ignite, burn, or maintain any wood, plastic, fiber pallet, petroleum, tire fire or smudge pot.
- 2. Exceptions to this order may be granted in writing by the District Superintendent, Ocotillo Wells District 5172 Hwy 78 #10, Borrego Springs, CA 92004.
- 3. Nothing herein shall affect any existing private contract or property rights.
- 4. Nothing herein shall be construed in derogation of other provisions of law.
