THIS ORDER SUPERSEDES ORDER NO. 690-034-2025

Wet Weather Closure

The use of off-highway vehicles (OHVs) within the eastern portion of Zone 3 and Zone 4 during periods of soil saturation and flooding have been identified as contributors to soil erosion and water quality degradation within Prairie City State Vehicular Recreation Area (PCSVRA). In order to combat these conditions within the park, a wet weather closure policy has been enacted.

No person shall drive within the closed portions of Zone 3 and Zone 4 during an area closure which will be closed using a series of gates within PCSVRA (map attached).

Exceptions to this order, at the discretion of the Gold Fields District Superintendent or his/her designee, may include:

1. Official use by a California State Agency.
2. Scientific use and research with appropriate State issued permits.

Nothing herein shall be construed in derogation of other provisions of law.
Nothing herein shall affect any existing private contract or property rights.

Exceptions to this order may only be granted in writing by the Gold Fields District Superintendent or designee at 7806 Folsom-Auburn Road, Folsom, CA 95630.
