DISTRICT SUPERINTENDENT'S ORDER No. 023-20-680-680

**Diablo Range District – Multiple Units  
Posted Order- Fire & Smoking Restrictions**


WHEREAS, due to the extraordinary critical fire danger present in California in fall 2020, multiple fires actively burning in the State, and

WHEREAS, due to the lack of CALFIRE and local fire agency resources available to fight fires;

The listed Park Units of the Diablo Range District below will immediately restrict fires, smoking and open flames as follows:

1. The restrictions will apply to all lands of Benicia State Recreation Area, Bethany Reservoir State Recreation Area, Carnegie State Vehicular Recreation Area, Fremont Peak State Park, Henry W. Coe State Park, Hollister Hills State Vehicular Recreation Area, and Mount Diablo State Park.
2. All open flames and fires, including wood or charcoal will be prohibited in park units listed in #1 until the end of the 2020 fire season as determined by the local CALFIRE unit (SCU).
3. In addition to Public Resources Code 5008.10, Smoking will be prohibited in all units, including on roads or trails, in campgrounds, in buildings, in vehicles or recreational vehicles, whether moving or not, and inside tents.
4. Lanterns and portable stoves using gas, jellied petroleum or pressurized liquid fuel and propane or gas fire pits are permitted in designated campgrounds or picnic areas. Visitors must clear all flammable material for ten feet in all directions from their camp stove or propane fire pit, have a shovel available, have water or fire extinguisher close by, and ensure that a responsible person attends the stove/pit always during use.
5. Exceptions to this order may only be granted in writing by the Diablo Range District Superintendent, 15751 Telsa Road, Livermore California 94550.
6. Nothing herein shall affect any existing private contract or property rights.
7. Nothing herein shall be construed in derogation of other provisions of law.


